**Called to order:**

Board Chairman McVicars called the meeting to order at 6:02pm

**Cave Lake Project-**Kody Menghini (NDOW) reported that the dam is getting smaller, and the lake is filling. Menghini stated that there will be a fish salvage held on June 21, 2023.

**8B.\* Heritage Project Extension Requests – Committee Chairman Tom Barnes.**

**Board discussion:** Menghini reported that there will be a restoration of aspen trees located in various areas of the county, such as the Snake range, and Weaver Creek, along with hand cutting continuing and the maintaining of Majors to Cooper Canyon. Smith Valley habitat restoration includes acres of maintaining erosion repairs.

**8D.\* Fiscal Year 2024 Heritage Project Proposals – Committee Chairman Tom Barnes.**

**Board discussion:** Menghini reported that springs restoration project near Weaver Creek have roughly 3,000-5,000 acres of hand cutting and de-mastication. The Steptoe Valley project pertains to a well that will be put in to supplement the filling of Cave Lake. Menghini stated that habitat restoration funds will mainly be put toward the properties that have been purchased near Blue Diamond and Success Loop, for fencing and rehabilitation and the collaring project in area 13. Chairman McVicars asked if the recreational areas, such as the camp sites at on Success, would still be accessible to the public. Menghini stated that it is still to be determined and that the department is still working through titling issues for some properties. Trevor Marques asked if the land purchased will be public or private. Menghini stated that it would be under the public land division. Chairman McVicars mentioned poor fencing in the Sage Hen area. Menghini reported that he has intentions to reach out to the landowner for repairs or demolition.

**Board discussion:** Board member Sawyer asked what the difference is between the Merriam and the Rio Grande was. Menghini responded that the Merriam breed of turkeys seems to do better in this climate than Rio Grande.

The motion carried with no opposition.*

**Public comment:** Trevor Marques stated that he would like to see the Governor's tag alternate units for elk as they do for sheep. Marques voiced, sportsmen that have waited years to become eligible in the draw to hunt a once in a lifetime bull, lose out on the opportunity when the same units are hunted during the Governor's hunt. Chairman McVicars agreed and stated that it should be rotated with all species. Kody Menghini encouraged the topic be brought to the Commission's attention at the next meeting.
